



# Australia & USA Defence Export Control

Goal will soon be launching an online Export Control course. Perfect for induction training of new employees/contractors or existing employees who need to refresh their knowledge.

ITAR (International Traffic in Arms Regulations) controls the transfer of US origin Defence Articles, Technical Data and/or Defence Services. Controls affect both the export and the re-export or re-transfer of those controlled goods.

An export occurs when an ITAR controlled item is transferred to a Non-US citizen; no matter the form of transfer or the location.

Export controls need to be taken seriously as failure to comply could result in penalties, delays, loss of business or worse. There are severe potential impacts to companies and their employees for breaches of the export control laws and regulations.

Therefore it is imperative for management and staff of any company working in, or associated with, the Australian Defence Industry to understand the requirements and their obligations under ITAR legislation.

This course provides participants with an overview of the requirements of managing Export Control in the Australian Defence environment. It also covers the requirements involved in sending & receiving controlled goods, handling/processing Defence items, reviewing technical publications/documents and provides vital information for senior managers.

### Course Overview

Export controls are not in place to impede trade but rather to ensure goods and technologies being exported from Australia are consistent with our strategic and security policy objectives.

Export controls provide a level of scrutiny of goods and technologies that allow the government to make a decision as to whether the export is in Australia's best interest.

The course identifies and discusses the Australian Export Controls, the United States requirements and explores the current best practice Export Control Management Systems (ECMS) that meet both sets of controls.
