



# MoR® Combined Course Outline

Management of Risk (M\_o\_R®) provides a generic framework for the management of risk across all parts of an organisation, whether it is at the strategic, programme, project or operational level. The M\_o\_R® guidance brings together recommended approaches, checklists and pointers to more detailed sources of advice on tools and techniques. M\_o\_R® is aligned with ISO31000, but provides detailed guidance on how to embed risk management in an organisation.

## Who should attend?

This course is aimed at anyone working within a corporate governance environment who has responsibilities for identifying, assessing, planning, or managing risks, or reporting on risk management activities across the organisation.

## Course Objectives

The **Foundation** course will enable delegates to:

- Know the facts, terms, concepts and relationships between the four elements of the MoR framework (principles, approach, processes and embedding/reviewing);
- Understand how the MoR principles, approach and processes are used;
- Be able to identify the MoR framework documents and understand their uses and differences.

The **Practitioner** course will enable delegates to demonstrate their ability to:

- Understand the relationships between the four elements of the M\_o\_R® framework;
- Be able to apply the principles, approach, processes and techniques;
- Be able to review and make recommendations to embed the M\_o\_R® framework;
- Be able to create and assess any of the MoR framework documents.

Delegates will be fully prepared for the Foundation and Practitioner exams.

## Course Duration

4 Days.

## Prerequisites

There are no prerequisites for the course, however some exposure to risk management would be useful. Candidates for the Practitioner exam must have previously passed the Foundation exam.

## Course Content

The following topics will be covered in the Foundation course:

- Organisational context of risk management, governance and control;
- Principles of risk management;
- Approach: Policies, strategies and processes; planning; monitoring;
- Perspectives: strategic; programme; project; operational;
- Risk Management Processes: Identifying and analysing risks; planning for implementation of countermeasures; communication;
- Embedding and Reviewing Risk Management: awareness; behaviours; commitment;
- Exam preparation

The Practitioner Seminar is scenario based and focuses on the application of MoR under different perspectives and scenarios. Review and revision sessions of all MoR elements are included throughout the training. Delegates will work through a range of exercises and case studies in order to broaden & deepen their understanding of Risk Management and to prepare for the exam.

## Exams

The Foundation exam is a 60 minute closed book, multiple choice exam. The Practitioner exam is a 3 hour objective testing open book (M\_o\_R® Manual only) exam.

At least 50% of the questions must be correct to pass either exam.
